Modesto, California - Stanislaus County District Attorney Birgit Fladager announced today that virtually every single resident of Stanislaus County has been affected in one way or another by the terrible plague of methamphetamine. Use of the drug leads to an addiction that is overwhelmingly powerful and very difficult to overcome. The impacts on the human body are devastating, long-term and potentially fatal. The addiction invariably leads to criminal behavior. Babies are born drug-addicted. Children drop out of school. Families are destroyed. And then there are the lesser evils: homes burglarized, cars stolen, copper wire ripped from construction and agricultural sites, and toxic waste, the by-product of methamphetamine production, dumped in orchards and on farmland.

Stanislaus County residents need to know more about methamphetamine and the serious dangers associated with it. This information must be shared with our children, friends, neighbors and anyone we care about. An extraordinary opportunity exists to spread the word. A half-hour documentary called "Crystal Darkness" will air tomorrow on March 26th on most local Sacramento TV stations at exactly the same time (6:30 pm) to maximize exposure -- Please see the attached press release from the Office of the Attorney General.
